

THE ORGANIZATION FEEDS MORE THAN 80,000 POUNDS OF FRESH, HIGH QUALITY, SPECIES-SPECIFIC FOOD EACH WEEK AND UTILIZED 64 STAFF AND MORE THAN 165 VOLUNTEERS TO CARE FOR THESE ANIMALS. THE SANCTUARY ALSO SUCCESSFULLY REHABILITATED MORE THAN 204 ANIMALS TO HELP TRANSITION THEM INTO ITS LARGE ACREAGE FREE ROAMING HABITATS.

PUBLIC EDUCATION - THE SANCTUARY OPERATED AN ON-SITE PUBLIC EDUCATION PROGRAM FOR MORE THAN 155,000 PEOPLE IN THE DENVER METRO AREA, NATIONALLY AND INTERNATIONALLY IN 2019, AND WAS ABLE TO REACH ANOTHER 320,000 HOUSEHOLDS THROUGH DEDICATED MAILINGS OF ITS QUARTERLY NEWSLETTER. MORE THAN 62 SCHOOL FIELD TRIPS AND 55 ADULT EDUCATION OUTINGS WERE ACCOMPLISHED IN 2019.
